Protestant denominations, churches, and individual sects in Guatemala since the 1880s (includes all Protestant groups and their individual houses of worship over time by location. The data set currently has over 15,000 individual churches in Guatemala, identified by type, date of establishment; schools by each group as well as clinics and hospitals, radio stations and radio programs, theology/Bible schools.)

Translations of the Bible and Bible portions into indigenous languages of Guatemala by Language, date of translation(s), names of missionary and indigenous translators, Publisher, number of copies printed.

Moreria data set on rentals in Guatemala over time (this data set includes the date of the rental of costumes, the type of dance the costumes belong to, the characters corresponding to the costumes, rental fees, location of the dance for which the costumes are being rented, duration of rental, sometimes the names of the renters are included along with their role in the performance of the dance.)
