Assume that the grammaticality judgments provided here are correct. Additional data can be based on your own intuitions, but make them explicit.

- Q1. Provide an analysis why the following DP is ungrammatical (you can draw a tree). (5%)
- *1. A silk Roger's tuxedo

Motivate your answer using X-bar. Hint the following string is also bad (no need to draw a tree of the hint).

- *2. Large the book
- Q2.A. Draw a tree structure diagram of the following sentence. Use X-bar. Do not use abbreviated triangles (if you find the sentence marginal assume it is OK). (30%)
- 2. A politician's close friend had asked if the senator's legacy would survive the scandal
- Q3A. The sentence below has two meanings involving the underlined string. Show those two meanings (total 20%)
- 3. Beth saw the man in jail
- Q3.B Draw complete tree diagrams that capture both meanings.
- Q3.C. By making reference to principles of X-bar and phrase structure explain why 3 cannot mean that Beth was in jail but the man was not in jail?

- **Q4**.A Consider the following sentence. Draw a full tree structure (treat the underlying string as a CP modifying the nominal, just like a PP would). Do not use triangles. (total 30%)
- 4a. Darwini's theory that dinosaurs speak to himi surprised scientists.
- Q4.B Using binding theory, explain why 'him' and 'Darwin' can be co-indexed.
- Q4.C Indicate how your answer accounts for the grammaticality of the sentence below (you do not have to draw a tree by you can):
- 4.b Darwin_i's theory about himself_i is controversial.

Q5. (15%)

A. Underline and draw the structure of the string that *one* refers to in the following sentences:

- I like this yellow book on syntax but I do not like that **one** on phonology
 - b. I like this yellow book on syntax but I do not like that red **one**
- B. State the structural requirement for *one* replacement, try to be as general as possible.
