

US Hospital Characteristics Associated with Price Transparency Regulation Compliance

Description of the data

The data include hospital-level compliance with the CMS Hospital Price Transparency Rule as of December 2021.² For each hospital, the *compliance* variable takes the value 1 if we were able to locate a standard charges file for that hospital (by December 2021) that contains any private payer-specific negotiated prices at the service code level.

Starting with the hospitals contained in the 2017 American Hospital Association (AHA) hospital directory, we merge in public data from the [2020 CMS Provider of Services](#),³ Hospital and Non-Hospital Facilities file (POS), and 2017 Dartmouth Health Atlas [hospital tracking file](#) (Dartmouth).^{4,5} We exclude hospitals that are exempt from the transparency rule, including federal and tribal hospitals, as well as integrated health systems that do not accept other insurance plans (i.e., Kaiser Permanente).

The final data contains N=4,484 hospitals. Ji and Kong 2022¹ further collapse these data to the health system by HRR level, which yields 2,892 hospital systems.
