Liav Orgad is an Assistant Professor at IDC Radzyner School of Law, a Marie Curie Fellow at the Freie Universität Berlin, and a Faculty Fellow at the Edmond J. Safra Center for Ethics at Harvard University. His research interests include constitutional identity, citizenship theory, comparative immigration law, and international jurisprudence. In recent years, Orgad was a Fulbright Scholar at NYU Law School, a Jean-Monnet Fellow at the European University Institute (EUI), a Visiting Professor at FGV Direito Rio, and a visiting scholar at Harvard Law School, Columbia Law School, Universität Luzern, and the Roosevelt Academy, the Netherlands.

Orgad has published in the *American Journal of Comparative Law*, *American Journal of Law & Economics*, *International Journal of Constitutional Law*, and *European Law Journal*. His book, *The Cultural Defense of Nations: A Liberal Theory of Majority Rights*, is published by Oxford University Press (2015). Orgad's research was awarded the Russell Sage Presidential Authority Award and the Israel Science Foundation Grant. He has won the Dan David Scholarship Prize for "scholars of exceptional promise" (2013), the Fulbright Alumni Prize (2012), and the Eric Stein Senior Scholar Prize for "best scholarly article" by the American Society for Comparative Law (2011). He has been granted various scholarships, among others, Rothschild, Fulbright, Jean-Monnet, Marie Curie, and "Our Common Future" Fellowship by Volkswagen Foundation.
